














TABLETOP TRENDS



HERE'S WHAT WE'RE EXCITED FOR THIS SEASON

WOOD

Wood chargers are an easy way to add a rustic touch to any wedding table. We love seeing them used on farm tables, especially when the tables have been covered with linens, to pull that wood grain element back into the tablescape. The clean lines of our Timber charger keep the tables from feeling too western and outdoors-y, but just natural enough.

NATURAL MATERIALS

Speaking of natural materials, nature is a priority for those of us who live in Jackson Hole. Getting outside is not just a part of our daily habits, it's a lifestyle. We love bringing that spirit into events, like with our rattan glassware. The rattan mimics the tall grasses that sway in summer winds all over the valley.

ORGANIC SHAPES

Part of the fun of being married here is the ability to eschew tradition. The town's casual, relaxed vibe allows you to have a more causal and relaxed wedding. We love these Luster plates; the gold rim adds an element of glam and formality, but the organic shape of the hand-thrown and hand-fired porcelain keeps these plates appropriate for a ranch field. In other words, they are just fancy enough.

MIXED MODERN

Just because we're in the Wild West doesn't mean you can't go modern. Our Heath dinnerware is the perfect addition to any modern Jackson table. Made from clay, Heath's distinctive

unglazed edge adds that slight rustic touch and a hand-crafted character to the clean, simple lines. Mixing these pieces makes a tablescape feel rich and layered.

REFINED ELEGANCE

You can never go wrong with classic and simple, that trend will always prevail. The Bella Bianca collection is sweet, feminine and classic, and will always be in style. We suggest this option for anyone who is worried about going too western. Pair it with our horn or bone flatware for a nudge in the natural direction.

KEEP IT SIMPLE

You don't need a ton of rentals to keep your tablescape interesting, especially if you are hosting 250 people. Choose the hand painted Cézanne charger, created to mimic a barnwood fence with Teton sunset colors, for one impactful piece on the tables. Keep it clean and immaculate to complement your gorgeous flowers.

INTERESTING FLATWARE

Our slender Goa flatware brings in rich gold and a colorful handle to any setting. The handmade pieces come with natural blemishes that keep this from feeling too fancy. Don't let their delicate appearance fool you- these are weighty (trust us, they feel great in your hand) and sharp enough to cut most red meat. These are fancy, special-occasion pieces you may not use in your home daily. Our Sabre Horn pieces are a little less delicate and bring in those casual bistro vibes with an elegant touch to balance out any tablescape.

as well as reflected back on their southern
roots. Their wedding suite encompassed

traditional engraving on all pieces on 3-ply paper, paired with a vellum printed overlay and custom vintage postage. We debuted our Bella Bianca collection at the wedding as well along side Bistro horn flatware and Czech crystal stemware. Day of pieces included custom embroidered napkins for the head table, cocktail napkins, table numbers, escort and place cards, personalized welcome gifts hand delivered by xowyo to guests upon check-in, various signage and additional paper goods for all their events that weekend.







were looking for an elegant and simple variation of our Monica and John suite from 2018, cue in the gray and blue/teal watercolors. She was looking to tie in that whimsical watercolor look with more subdued and earthy colors and wanted a combination of hand calligraphy, natural textures and a slight Jackson Hole flair. See how this carried across all of her wedding papers, day of papers, signage, welcome gifting and more.

INSPIRED DESIGN PROCESS

OUR FAVORITE PAPER SUITES START WITH COLLABORATION, AND SO THE DESIGN PROCESS AT XOWYO PAPER + EVENTS BEGINS WITH A CONSULTATION IN OUR STUDIO, OVER THE PHONE OR ZOOM.

Before this meeting, please send us your inspiration (artwork, fashion, architecture, books, color samples, other invitations, photos from Instagram collections, Pinterest boards). We encourage you to think about your story as a couple and what elements of that story you want to share through your stationery. This is also time to think about your budget for paper goods. After our consultation, we'll come up with a price estimate for review. For custom and semicustom clients, our estimates are based on past experience with similar jobs and will offer an idea of cost. But because each client project is unique, the estimate is subject to change as the project evolves. Printing estimates may also change as the design evolves. We do track our time closely, and clients who request this service will receive a report every week of hours spent on their job.

LET'S DO THIS

If you decide we are a match, and agree to our cost estimate, we'll provide a contract including the details of your order. A 50 percent, non-refundable retainer is necessary to begin design.

LET'S GET TO WORK

Now comes the fun part! We will start developing your perfect design with a branding document derived from the images and other information you have provided. This phase lets us hash out the direction for your paper goods, before we start any of the actual design work. We will talk colors, fonts and motifs in this phase. The more direction and feedback you give us, the better. At this stage, we will also talk paper and printing options that honor your budget. Only when we have settled on a direction will we create the actual design. You will receive your custom design proofs in PDF format via email. These designs will reflect the ideas and inspiration discussed in our meeting and the initial design phase.

LET'S GET DOWN TO THE DETAILS

Now it's your turn to review our proofs and let us know if there are any changes to be made. With our custom and semi-custom clients, we don't limit the number of proofs you see because we are billing for our time. Clients who opt for The Collection are allowed two rounds of proofs, with each additional round of proofs billed at \$150. Once designs are almost approved, we can make any final decisions on paper and envelopes, color choices and any other details. This allows for final pricing adjustments before production.

LET'S PROOF, CAREFULLY PLEASE...


Once you have fallen in love with your design, we will send a final approval form before print. This is your time to triple check spelling, dates, times, fonts and colors. Take your time, and have extra sets of eyes on everything. We are not responsible for mistakes after the final approval (those will be the client's responsibility). Upon approval and final invoice payment, orders can no longer be cancelled for any reason, and there are no returns. xowyo is not responsible for any costs associated with reprinting and shipping due to errors approved by the client.

LET'S MAIL!

Printing turnaround time varies depending on the style you choose (flat, letterpress, foil). Generally, printing, assembly and delivery takes four weeks. For brides who want an active role in their invitations, we can deliver your project ready to assemble; however, given the creative nature of our work, and all the hand-finished elements we use, we suggest using xowyo for assembly and mailing (an additional fee is charged and will be included in your quote).

PRICING AND PAYMENT

xowyo offers three levels of service, which means something for most budgets.



CUSTOM

If you're the type of client who prioritizes stationery, or who wants to take part in the creative process, then this is the option for you. Our custom invitations are designed from scratch. We love to tailor this to the specific event, and as such we create something one of a kind. Since this option is so unique, each job is quoted separately. With this collection, a flat fee covers design time, which means you can see as many proofs as you need. This option often utilizes custom illustration, hand painting or hand lettering and print methods such as letterpress and foil stamping. We also may create custom shapes through die cutting or laser cutting.

SEMI-CUSTOM

Let's say you like an invitation from one suite, and the reply card from another. Then our semi-custom option is just for you. With this route, we let you swap fonts, select custom colors and swap out any of our illustrations. With our semi-custom collection, our flat fee covers a certain scope of design work.

THE COLLECTION

The collection features a broad range of our most popular designs. These designs are also sold as shown, but xowyo will do a little of the work for you. We will change the words and colors (sorry, no font changes) and send you digital proofs. With The Collection, you are allowed one round of changes.

A LITTLE MORE ON PRICING

xowyo focuses on quality and providing an enjoyable and unforgettable experience. As such we only take on a certain number of clients every year. We open up custom work to just 12 couples annually. We take on 15 semi-custom couples, and 20 couples for our Collection. For custom and semi-custom clients, we charge a flat design fee that covers all work from the save the date and website to the invitation suite to dayof paper. This flat fee covers our all of our time spent thinking about your job, conceptualizing the design and creating your unique paper art. This fee will be provided in your custom quote.

DESIGN FEES INCLUDE



-Initial consultation

-All phone calls, in-person meetings and email correspondence with founder Cara Rank and two other staff members

 -A production calendar with all important dates up to the wedding or event, as well as monthly email reminders about those dates

 -A branding document (only for custom and semicustom clients)

-Website design and formatting (ongoing throughout or contract)

-All design work for save the dates, invitation suites and day of paper

Beyond our design fees, we bill for paper, other materials and printing. Please reach out with your head count and desired items for your custom stationery proposal and quote.

DESIGN + PRINTING

1 WEDDING BRAND

In search of a one of a kind look for your wedding papers, welcome gifting and event signage? Let us create a semi-custom or custom bridal brand to use on all of your wedding stationery and collateral for invitations, day of pieces, and welcome gifting.

2 PRINTING

It's always important to discuss paper and printing methods. Part of what makes your event paper special is the process you use to produce your wedding suite. We offer high end printing solutions including letterpress, engraving, foil stamping, embossing, debossing, blind impressions, thermography, offset printing, flat printing, digital printing, die-cutting, embroidery, laser cutting, and screen printing. Different printing processes and papers will factor into the presentation of your wedding suite and convey what style of event you are throwing. We can mix and match printing processes and papers to fit within your budget as well. For example, you may choose letterpress for your wedding suite and save money by printing the remaining pieces digitally. The options are endless but nevertheless should be an important consideration in the wedding paper design process.

3 FINISHING

Finishing is a term used in the paper world that is part of the final printing processes. Finishing looks like gilded edges, edge painting, beveled edges, die cutting, duplexed paper (different colored papers laminated together), rounded corners, die-cut corners, hole punching, grometting, scoring (for folded pieces) and binding (for stitched pieces like booklets or pamphlets).

4 CALLIGRAPHY

We include this right below the printing processes because it is for our discerning brides who are looking for that beautiful hand calligraphy wedding suite. Depending on budget, we want to make sure we have enough time carved out to include calligraphy in the process. Some suites we have done are 100 percent calligraphy (See Real Wedding: Mary Scott + Campbell), and other wedding suites include just done the bride and grooms names or envelope addressing only. The beauty of calligraphy can't be matched elsewhere and is something we take pride in outsourcing to only the best calligraphers.

SAVE THE DATES

5 SAVE THE DATES

This card is sent out 6-12 months before the wedding to allow guests to mark their calendars and begin making travel/accommodation plans. These can be as simple or as elaborate as you wish. Many couples list their wedding website here to update guests on important details. We also can do an electronic card if you are pressed on time and have a short engagement.

6 BASIC WEDDING WEBSITE

If you are looking for a simple wedding website to direct your guests to more information about the weekend's events we can create a single landing page that includes anchored sections on the home page for info on travel to Jackson, a list of wedding events, hotel and accommodations info, and registry info.

7 CUSTOM WEDDING WEBSITE

If you need more than the basic wedding site, let us create a custom wedding website that will include everything from the above website package, and the following add-ons. Individual pages for the following travel to Jackson Hole, Eat and Drink, To-Do (a custom activities list of your favourite things to do in the area or use our curated list), Shopping (with links to all your favourite storefronts), Couples Gallery, Area Map, and inclusion of all transportation and welcome letter info. All our custom wedding websites are branded to match our client's bridal brand, and event stationery.

INVITATION SUITE

8 INVITATION

Who, what, where, when...your wedding invitation gives guests the nitty gritty information and a sneak peak into the style of your wedding. We like to send 10-12 weeks before your wedding date. A wedding suite typically includes, at a minimum, your invitation, reply card, reply card envelope and mailing envelope.

9 REPLY CARD + REPLY ENVELOPE

We prefer to send these as a traditional card and envelope. Lastly, we like to collect hotel and accommodations information on this card for gifting later.

Or, use this card for extra info such as travel, accommodation details, addresses, contact numbers, website and or even menu descriptions.

12 TAGS

Perfect for a wedding website, guest information or just a fun quote or welcome note! We have printed these on leather, wood, laser cut paper, and fabric. We can customize tags to individual guests names or print a specific message on them.

13 MAF



FREQUENTLY ASKED QUESTIONS

HOW DO I GET AN ORDER STARTED?

After we've had a phone or in-person consultation, you will receive an estimate for your order. If that looks good, we will whip up a standard design agreement for you to sign, and send an invoice for a 50 percent deposit. Once we receive both, we will get started.

WHAT IF MY ORDER CHANGES FROM WHAT'S IN THE AGREEMENT?

The design agreement is by no means set in stone! It is just a good starting place for both parties. If you decide against an envelope liner or change your quantity after the contract is signed, no problem, those items can be updated along the way.

TIMELINES & PROOFING

It's always better to have more time than not enough, so contact us as soon as your wedding date and venue are set. If you're on a tight timeline, no need to panic! Most timelines can be accommodated. During our initial consult, we will also pick some key dates to build a timeline before starting your job so we all know what to expect and when.

WHEN SHOULD I ORDER SAVE-THE-DATES?

For save-the-dates, you should order as soon as your venue is booked and mail them to your guests six to 12 months before the wedding.

WHEN SHOULD I ORDER INVITATIONS?

It's best to order about four to six months before the wedding date, or as soon as you know the guest list size. Order early enough to allow time for printing, addressing, assembling and mailing your invitations six to eight weeks before the wedding date.

WILL I GET TO SEE A PROOF BEFORE MY ORDER IS PRINTED?

Absolutely! Since every design is customized, the proofing process is the most important step of all. Unlike many stationery companies, we don't cap the number of proofs you receive. We are happy to go back and forth with electronic PDF proofs until we get your design just right. When we get to the final proof, be sure to have at least two other sets of eyes proof everything very carefully for both spelling and accuracy since reprints are full price in most instances. Unfortunately, xowyo cannot do color proofs in most instances. The set up costs associated with printing are high, so it is cost prohibitive to print just one sample. (We can do samples for flat printing.)

HOW LONG WILL IT TAKE TO GET MY ORDER?

Ideally, we email your first digital proof within two weeks of receiving your signed contract and deposit. You should expect the custom design and proofing process to take four additional weeks from that point. Please factor in another two to three weeks for printing and shipping. So what we're saying is please plan on eight to 10 weeks for the whole process. If this doesn't work, we can expedite your order for a rush fee (those vary depending on the complexity of the job). These are the shipping day timelines from final proof approval and payment:

Handkerchiefs/muslin: 3-5 weeks

Letterpress: 4 weeks (3-week rush is available for a 30% fee)

Flat print: 10-14 business days

MAILING ETC.

CAN YOU ADDRESS MY ENVELOPES OR POSTCARDS?

We can print your addresses for a fee of \$2/ envelope. We also have two fantastic staff calligraphers who can help you.

HOW MANY EXTRA ENVELOPES WILL MY CALLIGRAPHER NEED?

We recommend ordering 20 percent extra envelopes for calligraphy mess-ups.

CAN YOU TELL ME HOW MUCH POSTAGE EACH INVITATION WILL REQUIRE?

Unfortunately, every post office judges the postage price differently. Our post office might say 49 cents is sufficient, while another says 65 or even 85 cents. It's best to wait until you receive your order and take a complete set to your local post office to be accurately weighed to ensure your guests receive their invitations. We can provide you with a postage estimate, but you should always confirm the final postage amount with the local post office from where you plan to mail. On average, our save the dates or announcements range from 46 cents to \$1 in postage while our wedding invitation sets range from 1-2 in postage. Two important items to remember when mailing: stamp the reply envelopes in your invitation set as a courtesy to your guests, and all square sizes require 20 cents extra postage



THE POST OFFICE DAMAGED/LOST MY INVITATIONS. IS THAT MY RESPONSIBILITY OR YOURS?

Unfortunately beautiful invitations can sustain damage during mailing. We've even had a few get lost. After you've confirmed the correct postage, we recommend asking the post office to hand cancel your invitations to help them stay in tact. Once the invitations are out of xowyo's hands, we can't certify that anyone else will baby them like we do. So if paper rips, ink bleeds or the postman loses something, we can help replace it. But we can't be responsible for the replacement cost.

WHAT IS HAND CANCELLING?

Hand cancelling is when the post office stamps a seal over the postage as opposed to running the envelope through a machine. If you can convince your local post office to do this for you (we bring our gals cookies), we highly recommend it. It will help ensure your invitations arrive in the best condition possible

DO YOU OFFER STUFFING, STAMPING AND MAILING SERVICES?

Yes, xowyo offers these services as an added convenience. Pricing for this service will be outlined prior to your design agreement.

SHIPPING

WHAT DOMESTIC SHIPPING OPTIONS ARE AVAILABLE?

We ship via USPS, UPS or FedEx. Let us know if there is one you prefer.

THE FINE PRINT

WHAT ARE YOUR PAYMENT REQUIREMENTS?

We require a 50 percent non-refundable deposit with your signed contract. We require the balance upon printing.

WHAT ARE YOUR REFUND AND CANCELLATION POLICIES?

If you decide to cancel before we've printed your order, we will retain your non-refundable 50 percent deposit. If you decide to cancel your order after final approval is made, we reserve the right to keep the full payment amount. Because every xowyo order is custom, we do not accept returns or offer refunds. If errors are found after final approval is made, the cost of a reprint is the client's responsibility.



I AM CANCELLING MY ORDER. CAN YOU GIVE ME MY ARTWORK?

While we hope it never gets to this point, if you decide to cancel your order we cannot give you any artwork we have completed for you. You've paid us to design artwork, but you don't own the rights to it.

I AM UNHAPPY/FRUSTRATED/ANNOYED WITH YOU. WHAT DO I DO?

If for some reason you are unhappy with something, please talk to us reasonably because we love our work and really want you to love the work we create. If you go bridezilla (or groomzilla) on us, we reserve the right to end our working relationship immediately. Please just pick up the phone and call us to talk through whatever issue you are having. As problem solvers we want to find a solution.

• IMPORTANT POLICIES •

PROPOSALS / ORDERS

• A \$500 rental minimum for all orders is required unless otherwise agreed upon beforehand. If the rental inventory total does not meet the minimum, an adjustment line item will be added to the invoice in an amount needed to meet the minimum. That amount cannot be used toward fees, labor, the damage waiver or a future event.

- Rentals are for one-time use only. In the event that client requests to reuse already used inventory, client is required to obtain permission from xowyo. Client may be billed for the additional use. Client assumes responsibility and legal liability resulting from the reuse of rental inventory.
- Proposals are estimates based on the availability of product under certain circumstances. If your needs
 change between the time a proposal is sent and when the order is taken and a retainer made, xowyo
 reserves the right to make adjustments as necessary.
- Proposals are good for one week from the proposal date. If after one week a retainer is not paid, items will be released to other interested parties and/or rates may change due to availability. If an order is not secured by the end of the proposal period, xowyo will not be responsible to confirm the client's interest if another party inquires about the same product. For orders that are less that one month from event date, no proposal period will be allotted, as items are rented on a first come, first serve basis.
- If another inquiry is made that conflicts with an existing and unexpired proposal, xowyo will notify the existing client. At that point, a retainer will be required within 24 hours of being notified. If a retainer and signed rental agreement is not received within the 24 hour period following notification, then the items will be released to the other party.

RENTAL TERMS AND AGREEMENT

- To confirm an order we require your contact information (address, phone, email), valid credit card information and a non-refundable retainer. The retainer is equal to 50 percent of your order total and is applied toward your final balance. This payment can be made by credit card, cash or check. A valid credit card must be placed on file with us, even if paying for the order by check or another form of payment.
- A signed contract will be required in addition to the retainer to secure all orders. At this time it is important to raise any questions regarding the content of this agreement as it is a legally binding contract between the client and xowyo.
- Estimated labor rates for delivery, setup, scullery and pickup are subject to change based on the final timeline for the wedding day and may be dictated by when tables must be photo-ready and planned length of dinner service.
- Security Retainer. In addition to the price, client may be asked to pay a security retainer to ensure the return or replacement of damaged, destroyed or missing items, as well as fees related to the order. If that is the case, xowyo will charge the authorized card 14 days prior to the event for the security retainer amount. This amount will be refunded to the original card after the event, minus any costs to replace inventory and recover fees related to the order.
- xowyo reserves the right to use any and all design information and event photography for marketing, advertising, social media and/or portfolio use. In doing so we do promise to do so tastefully. If client seeks to restrict use, xowyo must be notified before the order is placed. Additional fees for such restrictions may apply.
- It is the client's responsibility to ensure that all information, including but not limited to, rental inventory collections, quantities, delivery/pick up information and timing is accurately listed on the invoice. The quantities listed on the invoice are the exact quantities delivered. xowyo does not build in any overages.

REDUCTIONS AND CANCELLATIONS

• Cancellations and/or reductions to the order once the retainer has been placed will be considered on a case by case basis. Typically, should the client wish to reduce counts/items after the retainer has been placed, xowyo will require the client to supplement that reduction with other available inventory. If no other inventory is available, then the client may forfeit the loss. Notification of the need to do so must be made a minimum of 14 days prior to the date of set up/pick up.

BREAKAGE, IMPROPERLY CLEANED OR MISSING ITEMS

- We understand that accidents happen. In the event of a damaged or lost item, replacement fees will be charged in accordance with the damage waiver policy. Once the order is returned and the missing or damaged items confirmed, an invoice will be sent within 10 days.
- If xowyo is not providing table setting and scullery, client is responsible for ensuring they order extra product so that there is enough on hand for the event in case the venue or caterer breaks items during setup.
- All crates, racks, and containers are considered part of the rental order and are subject to replacement fees if damaged or missing.
- In instances where client opts for table setting and/or scullery and repack services, xowyo will assume responsibility of broken or damaged items while those items are in our physical possession. If an item is stolen during service or dropped, broken or damaged during service by a caterer, wedding planner or another part of the team not associated with xowyo, it will be the client's responsibility to cover replacement costs for these items. The damage waiver is available to cover these instances.
- If you discover missing or damaged items upon receipt of your order, please contact us immediately so that we can replace the items if desired. We cannot accept disputes after an event is over. All that said, we do our best to ensure your order is complete and count items multiple times before leaving the warehouse.
- If for some reason an item you have reserved and rented becomes unavailable before your event, we will make every
 attempt to locate replacement product. If an exact replacement cannot be secured, we will fulfill your order with
 similar product.
- We ask clients to inspect the rental inventory upon delivery or pick up. If you do not notify xowyo of defective, missing or incorrect inventory within 2 hours of delivery or pickup, we assume you have accepted the inventory in its condition.
- Client acknowledges there may be some normal wear and tear that is not readily apparent in preparing an order for delivery. These minor defects do not constitute a breach of contract.
- Between the time of delivery and pick-up, the client agrees to provide a secure storage location for rented items and accepts all risk until items are loaded onto the xowyo truck or returned to our warehouse. If any items are damaged due to weather or unexpected elements, replacement or repair costs will be incurred once items are returned and the damage is assessed.
- Items do not need to be washed before being returned to xowyo; however, we ask that items are rinsed and/ or scraped clean of food debris. Dinnerware should be returned "dishwasher ready". You will be provided with instructions on how to care for items if xowyo is not providing scullery.

OPTIONAL DAMAGE WAIVER

- The client is responsible for rental items being returned in the same condition in which they were received, except
 for ordinary wear and tear. The client is also responsible for the replacement cost of damaged or lost items. Our
 optional damage waiver is available to protect you from damage due to accidental breakage. No misplacement or
 theft of any type will be covered.
- The damage waiver is available for a fee of 10 percent of the total rental inventory order, excluding labor. The damage waiver is not a refundable item. If waiver is accepted and damage occurs, coverage will be calculated based on the size of the original order:
- Orders totaling \$1,000 or less: 100 percent of the damaged items' replacement cost is covered up to 25 percent of the total rental cost. Any damage exceeding 25 percent of the total order will be covered at 50 percent of replacement cost.

Orders totaling over \$1,000: First \$200 of damaged items' replacement cost is covered. Any damage over \$200 will be charged at 50 percent of replacement cost.

- The damage waiver waives you of liability for rented items that are returned damaged due to an accident. You must return all broken or damaged items and other such evidence that we may reasonably require.
- The wavier is secondary to your own insurance. Some homeowner and business insurance may cover you for damage
 to rented items in the event of a sizable claim. Please check with your own insurance company if you'd like to seek
 coverage there instead of through our damage waiver.
- The wavier does not cover intentional acts, vandalism, misplacement or theft. If deemed necessary by xowyo, you agree to furnish a police report upon their request.

RENTAL PERIOD

•Our standard rental period is up to three days. We may accommodate longer rental periods, given availability. Rates are detailed below:

1-3 days: Base rental rate 4-7 days: Base rental rate X 1.5 8-14 days: Base rental rate X 2 15-21 days: Base rental rate X 3 21-31 days: Base rental rate X 4

MISCELLANEOUS

- Client will not sublet, loan or assign the rental inventory. Rental inventory shall not be moved from the address at which rentals were to be used. An additional fee may apply if moved from the rental location.
- xowyo is not be responsible for any damage to lawns, grass, flooring, tracks, scullery tables or any other surfaces on which xowyo reps must drive, walk, deliver or perform services.
- Client assumes full responsibility for any risk of bodily injury, death or property damage arising out of or related to xowyo items.
- In the event of rentals for styled shoots or promotional use, client is responsible for all obligations under this agreement even if inventory is provided at no cost.

SCULLERY NEEDS

- 10x10 or 10x20 tent for storage, organization and staging (based on size of event and rental order)
- Three, 8 foot banquet tables (if scullery tent is visible to guests you may want linens to cover one receiving table)
 - 4-6 chairs for staff, depending on size of the event
- 4-6 vendor meals for staff, depending on size of the event, optimally served before dinner service for guests begin
 - Lighting for tent area
 - Heater for tent, weather permitting
 - Two trash cans with liners (note: this does not include removal of trash from site)

HELPFUL EVENT INFORMATION

- Timeline for event weekend/day
- Description of service/order of meal (I.e. preset salad)
- Confirmation of who is doing linens. Linens, florals and chairs must be placed and ready to go in order to begin our service.
- Bussing timeline and procedure: Can all rentals be removed after dinner? Does anything need to remain on the table for the whole event?
- Transportation details: can a rental truck park near staging tent? Can a truck or vehicle leave during the event with a load?
